Terms and conditions of the 10th International Reenactors Fair in Minden

Article 1: The Reenactors Fair will take place on October 2nd and October 3rd 2021 in Minden (Germany). It will cover the periods going from the Prehistory to the Belle Époque.

Article 2: The Reenactors Fair shall take place in a festive, welcoming and quality-oriented atmosphere. Therefore we expect a willing of collaboration from all participants.

Article 3: Each participant wanting to participate has to fill in a registration form.

Article 4: The organizer will decide the acceptance or rejection of each registration form. Not invited or rejected participants will not be admitted to the market.

Article 5: The main selection criteria will be:

- the products historical authenticity
- the products quality,
- the available stocks. _

Article 6: Opening hours to public will be:

- Saturday, September 02nd: from 10am to 8pm Sunday, September 03rd: from 10am to 6pm

Booths need to be ready on Saturday at 10am at the latest. The tent will open for participants at 7am on Saturday and at 9am on Sunday.

Article 7: The space will be planned on the official booth map and will be allocated by the organizer following priorities depending on:

- the registration's chronological order,
- the seniority,
- the installation possibilities and the booth's dimension

Article 8: The participants should wear historical costumes and also decorate their booths in the same spirit.

Article 9: No electrical plugging will be allowed (except special authorizations).

Article 10: Gas bottles will not be allowed.

Article 11: Any item and equipment brought by the participants will be under their own responsibility. The organizer does not subscribe to an insurance covering these equipment and items.

Article 12: The participants must have all necessary authorizations for their activities. The organizer declines any responsibility if this rule is not followed.

Article 13: The rules given by the organizer meet the requirements of all local authorities as well as the firemen. Each participant undertakes to follow them precisely, whether they are written or told. Regardless of they are given before or during the event.

Article 14: Signing this registration form, the participants accept the conditions given here above.

Article 15: Any participant not respecting these conditions will have to leave the market.

Article 16: Force majeure is in particular an event or circumstance which, in any case, prevents a party from fulfilling the contract, even partially, and which is outside the sphere of the party concerned. Force Majeure events include war, natural disasters, fires and explosions, social conflicts, but also the Covid-19 pandemic. With respect to the Covid-19 pandemic, if the level of danger identified by the Robert Koch Institute in the location/situation reports is at least "moderate", both parties are exempt from the obligation to supply, provide or purchase for the duration and extent of the impact. This explicitly includes the organization of the event itself. In this case, the termination of the contract is considered legitimate, complaints and claims for damages, regardless of their reason, are excluded unless there has been intentional or serious negligence on the part of one of the parties or its executing agents.

Article 17: The legal consequences of a force majeure event also apply when, for other reasons resulting from the Covid-19 pandemic, the organization of the event is no longer economically feasible. These include the requirements imposed by the authorities and the expected behaviour of visitors, in particular as regards attendance and/or expected turnover.

Article 18: Apart from the two situations listed above, both parties undertake to implement everything that is reasonably and economically possible to organize the event. This includes strict compliance with hygiene requirements, whether requested by public authorities or by Minden Marketing GmbH..

Place rates

Inside place:

Depth	Rate (€ / linear meter for 2 days)
2 m	22
3 m	28

Examples:

- -2 m wide x 2 m deep inside place : 2 x 22 € = 44 €
- 6 m wide x 3 m deep inside place: 6 x 28 € = 168 €

Outside place:

Depth	Rate (€ / linear meter for 2 days)
2 m – 3 m	17
4 m – 5 m	22
6 m – 7 m	28
8 m – 9 m	33

Examples:

- 4 m wide x 3 m deep outside place : 4 x 17 € = 68 €
- 7 m wide x 5 m deep outside place : 7 x 22 € = 154 €
- 9 m wide x 9 m deep outside place : 9 x 28 € = 252 €
